Trademark Agencies Required to Go Through Record-Filing Formalities Again

The China National Intellectual Property Administration recently announced that service agencies and law firms engaged in trademark agency business must submit new applications for recordfiling between 1 January and 28 February 2023 even if they have already done so on or before 30 November 2022. The exercise must be completed by 31 March 2023.



Inland Revenue Department to relocate offices to Kai Tak
